Pre-State practice is never a guarantee, if there is a major tournament/site equipment repair needed, bad weather, or any circumstances delaying the setup of the tournament, the practice weekend can be canceled and not rescheduled. **There will be no deviation from the schedule, and delays to setup of the tournament may result in the forfeiture of your practice time.** All registrants must completely vacate the site promptly at the end of their time slot with no exceptions.

Pre-State Practice Guidelines:

1. Practice time sign-up will only be accepted at Think Tank. WWSF will post schedule by March 15th. Duration of practice slots will be determined based on volume of registrants, minimum time for each team will be 90 minutes.
2. Registrants may cancel their practice up to May 24th with no penalty. Cancellation after May 24, 2019 or failure to attend your practice time is considered failure to comply with guidelines and will result in penalties.
3. Registrants must submit proof that practice dates and location are sanctioned with USA WS at the time of registration for practice.
4. Practice will be monitored by the WWSF.
5. Saturday, July 13, 2019 – Water time starts at 8:00 am. Water time ends at 8:00 pm.
6. Sunday, July 14, 2019 – Water time starts at 8:00 am. Water time ends at 4:00 pm.
7. All boats launched must pay boat launch fee – this fee is only exempt during the WI State Tournament.
8. Site is not tournament-ready, including but not limited to: dock is not chained down, floaters may not be placed, water level is not raised.

9. Beach is closed (swim buoys are removed), but *the lake is open to the public* and not closed during Pre-WI State practice; the public has the right to be anywhere normally permitted. No interference with or rude behavior towards the public using the lake is tolerated.
10. Skiers, volunteers, and spectators must park in the grass field at all times. No parking on paved areas is permitted at any time.
11. Stone Shelter/Pavilion and Concession Pavilion use is not permitted by skiers, volunteers, or spectators. Public bathrooms may be used.
12. All equipment must be kept to the farthest west side of park, or farthest east side while team is using the bay dock. See the attached map.
13. All personnel, equipment, garbage, and debris are to be removed promptly at the end of the practice slot.
14. Sound systems are not permitted. A small portable speaker audible only at short ranges are allowed.
15. Failure to comply with all above regulations may result in penalties included but not limited to: an Unsportsmanlike Conduct deduction (as rules apply) to your tournament score, in addition to a monetary penalty in the amount of 50% of entry fee. Said monetary penalty/fee must be paid to return to good standing with the WWSF and be eligible to compete at WI State.

Release/Waiver:
